

ACCREDITATION REPORT TO THE N.Y.S. SHERIFFS AND DEPUTY SHERIFF'S ASSOCIATIONS.

The New York State Law Enforcement Accreditation Council met on June 8, 2006 in Albany, N.Y. at 10:00am. The following is a summary of the business meeting.

Program Updates:

- ✚ 28 new program assessors have received training which will bring the total to 101 assessors statewide.
- ✚ Two program manager workshops have been scheduled: September 12, 2006 in Albany and September 26, 2006 in Jamestown.
- ✚ An assessor training will be conducted for all assessors to improve conformity among assessors as they relate to specific standards.

Meeting Highlights:

- ❖ New councilmen Doug Robertson was introduced and welcomed to the Council.
- ❖ Owego Village Police Department was on the agenda for reaccreditation. However, the assessors had some concerns with standards and compliance. The Council voted to defer the reaccreditation until the assessment team returned to the department to reexamine the standards in question. The Council will review the assessors recommendations at it's December meeting.
- ❖ The next Council meeting is set for December 14, 2006 in Albany.
